Bobbi Walker founded Walker Fine Art in 1999, and opened the gallery space in June of 2002. She has been actively involved in the arts community in Denver for the last 15 years. In 2012 Bobbi was appointed to the Denver Commission on Cultural Affairs and is currently serving her 5th year as a commissioner. She is a Young Associates level member of the Denver Art Museum (DAM), and served on the Board of the DAM Contemporaries for 3 years.
